Sub- Approval for renewal of agreement of Fair Price Diagnostic (16 Slice CT Scan) services at Barasat DH, North 24 Parganas.

To,
Superintendent Barasat DH

Sir,

On basis of the recommendation from CMOH North 24 Parganas, dated 03-01-2020, renewal for agreement of 16 Slice CT Scan at Barasat District Hospital where Barasat Millenium Spiral CT Scan & Diagnostics (P) Ltd is the private partner, is hereby granted subjected to the following terms and conditions:-

1. The agreement will be effective from 29-11-2016 for a period of 5 years.
2. The amount pending recovery from the private partner on account of payment of concession fees at 20 % of the gross revenue on quarterly basis as per G.O no HF/PPP/19/2016/752 dated 29/11/2016 is Rs 36,60,501 (Thirty six lakhs sixty thousand five hundred and one only). The same will be recovered in 20 equal installments of Rs 1,83,030 (One lakh eighty three thousand and thirty only) by the Hospital Authority.
3. The installment has to be paid within 10th of the every month without fail. Even a single incidence of default in payment of dues will lead to termination of the present agreement without any chance of hearing and the authority will be free to float fresh tenders for CT Scan services.
4. The hospital authority will be responsible for taking immediate measures for termination of agreement in case of default of payment as mentioned in para 3 above.
5. Fresh Agreement in standard format may be signed between respective Hospital authorities and the concerned private organization. All terms and condition of the agreement will apply for the entire period as mentioned above. All dues including Concession fees and electricity has to be cleared till date by the PPP partner before signing of the renewal agreement.
6. The agreement will be prepared in non judicial stamp paper of Rs. 100/- by the private partners for running the Fair Price Diagnostic and Dialysis. It is also to be noted that the performance security has to be renewed in form of Bank Guarantee to be furnished by the private partners while executing the agreement. For EOM units the amount will be Rs 10,00,000/- for CT Scan, services. The performance security is to be executed with the concerned bank in non judicial stamp paper of Rs. 100/- . The duly completed bank guarantee needs to be provided as scheduled attached with draft copy of the agreement.

7. The possession Certificate has to be renewed as provided in the draft copy of the agreement.
