Reference above, as per records there are 6 FPMS where renewal is already pending or will be due within June 2019, for which proper recommendation with duly filled in Check list as per Annexure 'I' still awaited. This is causing operational problems, as without proper renewal agreement, Drug License may not be renewed by Directorate of Drug Control.

Also there are issues of pending electricity bills, rent etc. In some places the process of determining rent is yet to be initiated. Also in some cases if the partners do not want to continue services, the Hospital authorities have to recommend future action and existing partner's needs to clear all dues before such recommendations.
