ORDER

In reference to Advertisement (Vide Memo No. DH&FWS/KPG/22-23/1160/I-IX, Dt: 28/09/2022,) the following candidates (**Annexure-A**) are being intimated for engagement in vacant posts under NHM on temporary contractual basis with monthly remuneration as per revised remuneration structure (vide WB-SH&FWS Memo. No. HFW-27011/137/2020/1611, Dt. 23.02.2021). S/he would be posted under **Member-Secretary, Kalimpong DH&FW Samiti, GTA and CMOH -Kalimpong.**

The candidates (as per **Annexure A**) are hereby intimated to be engaged as per terms and conditions mentioned below:

- 1) The tenure of engagement would take effect from the date s/he joins this post.
- 2) The candidates are directed to join in their respective posts at the “**Office of the Chief Medical Officer of Health- Kalimpong**” with i) engagement order, ii) photo ID proof, iii) original testimonials of essential qualifications, iv) Caste certificate, if applicable, v) **Contract Agreement** copy in Rs. 100/= non-judicial stamp paper and vi) **Medical Fitness certificate** (in the given format, **Annexure B**) from a registered M.B.B.S. practitioner/ Govt. hospital.
- 3) The candidate(s) should join within **07 (seven) days** from the date of issuance of this order. If the 07th day is Saturday/Sunday or Govt. holiday, then s/he may join on the next working day.
- 4) The candidates failing to report for joining in this office within stipulated period may not be allowed to join later and his/her engagement is liable to be cancelled.
- 5) In case any candidate is unwilling to join the post OR any candidate selected for two/ more posts based on merit score and is unwilling to join in other posts (except one), s/he may intimate this office (at recruitmentkalimpong@gmail.com) through an official letter/ mail. The intimation would be treated as refusal to join the post(s) and the next candidate in panel, if any, will be called accordingly.
- 6) **This engagement is till 31.03.2024 initially. Thereafter, tenure of engagement will be extended after assessment of performance of the candidate.**
- 7) The service may be terminated by one month’s notice by either side.
- 8) If the candidate proposes to cease her/his work without covering one month’s notice, his monthly allowance would be deducted accordingly.
- 9) Monthly remuneration would be given from NHM Fund head. It may also be noted (vide WB-SH&FWS Memo. No. HFW-27011/137/2020/1611, Dt. 23.02.2021), that those who are joining between 29.12.2020 to 30.09.2024 against new entry point remuneration, will not be entitled for annual increment for 03 (three) consecutive financial years, i.e. 2022-23, 2023-24 and 2024-25.
- 10) Monthly working statement, wherever applicable, would have to be produced from respective Institutional/ Prog./ Nodal officers before remuneration bill is prepared.
- 11) The validity of the recruitment panel is for 1 year from the date of the publication of the result


