4. If the incumbent proposes to give up her work without covering 1(one) month's notice period, her remuneration will be deducted accordingly.

HFW-27011/137/2020/1611 dated 23/02/2021 point no. ii, " All new employees who have joined / will be joining between 29th December' 2020 to 30th September'2024 against new entry point remuneration as per memotandum vide no. HFW-27011/137/2020/1352 dated 29/12/2020, will not be entitled for annual increment for three consecutive financial years i.e., 2022-23, 2023-24 and 2024-25".
