**ORDER**

Fund release proposal to School of Tropical Medicine, Kolkata and Dr BC Roy PGIPS, has been received for procurement of kits and reagents in connection with testing of scrub typhus, leptospirosis and other routine public health lab functions.

In view of above, the undersigned is directed by the order of the Governor to say that the Governor has been pleased to accord Administrative Approval and Financial Sanction of **Rs 4,50,000 (Rupees four lakh fifty thousand)** in favour of Medical Superintendent cum Vice Principal, Dr BC Roy PGIPS and Director, School of Tropical Medicine, Kolkata for procurement of kits and reagents in connection with testing of scrub typhus, leptospirosis and other routine public health lab functions.

Out of the total sanctioned amount, **Rs 3,00,000** is placed to School of Tropical Medicine, Kolkata and **Rs 1,50,000** is placed to Dr BC Roy PGIPS.

**Accounts Officers of the concerned hospitals will act as DDO in respect of the fund being placed.**


The expenditure will be charged upon the Budget Provision under the Head of Account "24-HF-2210-06-101-013-50" during the current financial year 2021-2022.
