MEMORANDUM

The undersigned is directed by order of the Governor to say that the Governor has been pleased to permit 1(one) Medical Teacher of the West Bengal Medical Education Services as shown in the Annexure to undertake Post Graduate Courses of studies and trainings in the disciplines as noted against, at The Postgraduate Institute of Medical Education & Research, Chandigarh, for the session January 2022 and for that purpose the Governor has also been pleased to place him on the Trainee Reserve for the period of three years with effect from the date of his release from his present place of posting or till the completion of the University examination of the course for the first time whichever is earlier.

- 2. The Medical Teacher will draw pay and Pay & Allowances as admissible to him while posted in such Trainee Reserve posts in such manner as he drew at the time of his release from his present place of posting.
- 3. The Medical Teacher placed on Trainee Reserve is subject to the condition that he shall prior to his drawing Pay as Medical Teacher on T.R Officer, execute bonds in triplicate in the prescribed form undertaking to serve this State Government for a period of at least five years after completion of the course. The duly filled up bond should be submitted to Special Secretary (MERT) for acceptance.
- 4. The Medical Teacher placed on Trainee Reserve may be released by local arrangement from his present place of posting by the Concerned Controlling Authority, in order to enable him to join the course.
- 5. Meanwhile, if on scrutiny and vigilance verification, the candidate is found to have been suppressing facts or furnishing false information, or in case of any adverse report, his candidature will liable to be cancelled and appropriate administrative action will be initiated against.
- 6. The Joint Director of Health Services (Accounts) will act as the DDO in this regard while the Deputy Director of Medical Education, West Bengal shall act as Controlling Officer in respect of such Medical Teacher.

- 7. The Pay & Accounts Officer III, Kolkata, Pay & Accounts Office III, Accountant General, West Bengal and other concerned are being informed.
- 8. He shall obtain release order from the concerned Institution immediately after completion of the course and report to the Director of Medical Education, West Bengal for duties.
