Madam,

Administrative Approval was accorded in favour West Bengal Medical Services Corporation Limited (WBMSCL) for procurement of 200000 nos of Long Lasting Insecticidal Nets (LLINs) in phased manner vide this Department's order No 132–HFW-27039/15/2022-CD(PHP) dtd 3.6.2022.

Now, General Manager, WBMSCL, vide communication number mentioned under reference, has informed this Department that Award of Contract had been issued to selected agencies for procurement of 50000 LLINs at 1st phase and placed requisition of fund amounting Rs 1,96,87,425 for the said procurement.

In view of above, the undersigned is directed by the order of the Governor to say that the Governor has been pleased to accord Financial Sanction of Rs 1,96,87,425 (**Rupees one crore ninety six lakh eighty seven thousand four hundred twenty five only**) in favour of West Bengal Medical Services Corporation Limited (WBMSCL) for procurement and supply of 50000 LLINs to control Vector Borne Diseases in 2022.


The fund will be released from the head of Account **24-2210-06-101-013-50-00** in the current Financial Year 2022-23.

The fund sanctioned hereinabove is released and placed at the disposal of the Assistant Secretary and Drawing and Disbursing Officer, Department of H&FW Government of West Bengal who will act as the Drawing and Disbursing Officer for this purpose. **The Drawing and Disbursing Officer shall disburse the funds in favour of the West Bengal Medical Services Corporation Limited** by transfer credit to the deposit Account of the WBMSCL with Kolkata Pay & Accounts Office-III.

This order is issued in exercise of power delegated under **Finance Department Group O vide their U.O. 
