**ORDER**


For the purpose of effective and transparent management of blood transfusion services, the State Blood Transfusion Council (SBTC) has developed an IT solution, Web-based Blood Bank Management System, to capture all activities starting from the scheduling of camps to the issue of blood and components to the requisitioning hospitals. Project has been piloted and is successfully running at both IBTM&IH and Calcutta National Medical College & Hospital. Proposed system is expected to provide information on real time availability of group-wise blood stocks/components for the benefit of clinical establishments and general population.

Subsequent to the successful piloting, it had been decided to roll out the system in all State Government Blood Centres in phases. Accordingly, in previous 3(three) phases, total 34 Blood Centres have been selected across the State for rolling out the system, where deployment of system and training of personnel had been completed.

In the 4<sup>th</sup> phase, another 10 (ten) Blood Centres have been selected (List of Blood Centres mentioned in Annexure-1). It has been decided by the competent authority that from now on, all activities starting from scheduling of camps to issue of subsequently collected and tested blood units/components shall take place through this new system in those 06 Blood Centres.

This order is issued in public interest.


