have been observed from the attached documents of the instant case:-


- 1) In your Memo. Vide No. SSKM/NE/8398 Dated 19.10.2022, you have stated that the
incumbent had not intimated her local office before proceed on leave for the period
from 16.11.2020 to 16.02.2021 whereas, in a Corrigendum letter vide Memo. No.
SSKM/NE/9447 Dated 28.11.2022, produced by the incumbent as an enclosure of
her reply to Show Cause states that the local authority had been intimated about her
absence before proceed on leave. The copies are enclosed herewith for your kind
reference.

As the Corrigendum Memo has not been received in proper way, clarification
on this aspect is asked whether the information provided in your earlier Memo.
(No. SSKM/NE/8398 Dated 19.10.2022) was an inadvertent error, or the
Corrigendum letter was manufactured by the incumbent in a biased manner.

- 2) The incumbent has submitted her online leave application for Child care leave
dated 08.11.2020 (Physically submitted on 11.11.2020) & the joining Report on
17.02.2021 ((Physically submitted on 19.02.2021). It is observed that the joining
Report was forwarded by the local authority, but the leave application wasn't.
The copies are enclosed herewith for your kind reference.

Please clarify the facts, as observed by this end.


