NOTIFICATION

The Governor has been pleased to allow Dr. Debi Prasad Roy Chowdhury, now posted as Medical Officer, Asansol District Hospital, Paschim Bardhaman, who has completed **16 (sixteen)** years' continuous and satisfactory service from the date of his regular appointment in the said service without any promotion and with one advancement to the next higher scale and now enjoying the scale of pay of Rs.10,000 – 325 – 15,525/- (Scale No.17, R.O.P.A.'98) to move to the next higher scale of pay of Rs.12,000 – 375 – 18,000/- (Scale No.18, R.O.P.A.'98), and its corresponding revised Scale of Pay, Band-4B, Rs.28,000-52,000/- +Grade Pay of Rs.7,600/- (ROPA 2009) with effect from **27.10.2014** and to allow him to continue in his present place of posting until further orders.

On his entitlement to the higher scale of pay of Rs. 12,000 – 375 – 18,000/- (Scale No.18, R.O.P.A.'98), and its corresponding revised Scale of Pay, Band-4B, Rs.28,000-52,000/- +Grade Pay of Rs.7,600/- (ROPA 2009), the pay of the concerned Medical Officer shall be fixed in terms of Finance Department's Memo. No.3015 – F, dt.13.03.2001 as also under normal rules. Besides, the said Officer would also be entitled to the pay and allowances as admissible to him in terms of rules & orders of the State Government in force from time to time.

While giving the effect to the above benefits to the concerned Officer the date of his joining in the West Bengal Health Services on regular basis, AND NOT ON ADHOC BASIS, as also continuity of the service should strictly be verified by the heads of the institutions vis-à-vis the entries in his Service Book. Discrepancies, if any subsequently be found, shall immediately be brought to the notice of this Department for taking further necessary action prior to giving effect to this order in respect of the said concerned Officer.

The above benefit has been awarded under the modified career advancement scheme in terms of the Finance Department's Memo. No.3015 – F, dt.13.03.2001.
