District Hospital, Darjeeling & Kalimpong.

The undersigned is directed to say in connection with that consideration of the proposal noted above, the following supportive documents with relevant satisfactory clarification is required to be furnished :-

- (i) Whether 'Manual Contingent Workers' should be treated equally as the casual/daily rated/contractual workers as per F.D. Memo. No. 9008-F(P) dated 16.09.2011. If so, whether, they fulfill the criteria in all respect and become eligible to get the benefits as provided in the Memo No. 9008-F(P) dated 16.09.2011. This needs to be ascertained by the respective Administrative Branch and get to be certified by a competent authority;
- (ii) 'No Appointment Letters' were issued to these manual workers. Then, how does 10 years continuous service can be calculated as per F.D. Memo. No. 9008-F(P) Sub para-(i);
- (iii) It is said that the contingency workers were appointed against sanctioned post. But the category wise detailed break-up of the sanctioned post have not been shown. He is requested to show the break-up of the said sanctioned posts also clarify whether the posts have any approval of Finance Department.
