ORDER

The undersigned is directed by order of the Governor to say that the Governor has been pleased for (a) upgradation of the non-bedded Bagbanda Saiberia Primary Health Centre (PHC) under Barasat Block-II in North 24 Parganas to a 10-bedded (24x7) facility and (b) creation of a total number of 3 (three) additional posts under different categories and engagement of 1 (one) Karmabandhu for this purpose.

The recurring and non-recurring expenditure, if any, will be admissible as per existing norms after filling up of the posts sanctioned above.

The posts sanctioned for creation would have to be filled up as per extant recruitment rules in force and method of recruitment and transfer-posting in the respective cadre.

The order is issued with the concurrence of Finance Deptt. vide their U.O. No. Group P2/2021-2022/0314 dated 03/11/2021 and with the approval of Cabinet vide their No. 132 dated 12/12/2021.
