
MEMORANDUM

Whereas, Smt. Yasoda Khanal, Staff Nurse, Grade-II, attached to North Bengal Medical College & Hospital, Sushruta Nagar, Darjeeling has reportedly kept herself absent from duty on & from 14.03.2020 to 04.10.2020 i.e. for a period of 175 without prior approval of the concerned authority while she was posted in the same capacity at the same hospital causing immense problem to provide patient care services of the said institute;

And whereas it is also reported that during her absence, Smt. Yasoda Khanal, Staff Nurse, Gr-II moved to Delhi & Chennai in several times without prior permission of station leave from the concerned authority and it is obligatory on the part of every Government Employee to obtain station leave permission as per existing rules and as per existing rules and G.O. No. 2494-F(H) dated 25.04.2019;

And whereas, the above mentioned activities i.r.o. Smt. Yasoda Khanal, Staff Nurse, Gr-II, is highly irregular, unbecoming, insubordination to the higher authority and violation to Rule 34 of WBSR, Part-I and Rule 3 of West Bengal Services (Duties, Rights & Obligation of the Government Employees') Rules, 1980;

And as such, Smt. Yasoda Khanal, Staff Nurse, Grade-II, attached to North Bengal Medical College & Hospital, Sushruta Nagar, Darjeeling is hereby directed to **show cause** as to why her above mentioned period of absence shall not be considered as un-authorized one and accordingly Disciplinary Proceedings should not be taken against her for the reason stated above within 15 (Fifteen) days from the date of receipt of this Memorandum positively.


