In accordance with **Medical Termination of Pregnancy Act, 1971**, Sec 4 (b) and MTP Rule, 2003, Rule 3, the formation of "**District Level Committee**" under MTP Act, 1971 for five (5) **Health Districts** namely **Bishnupur, Rampurhat, Nandigram, Diamond Harbour and Basirhat**, the following persons shall be nominated as members of that committee for the purpose of the same Act with immediate effect and until further order:-

a.	Chief Medical Officer of District	Chairperson
b.	One Gynecologist or Surgeon or Anesthetist, nominated by CMOH	Member
c.	One from the local Medical profession, nominated by CMOH	Member
d.	One from the non-governmental organization, working in the relevant field -- nominated by District Magistrate	Member
e.	One from the Panchayet Raj Institution of the District, nominated by Zila Savadhipati.	Member

Provided that (i) one of the members of the committee shall be a woman, (ii) tenure of the committee shall be for two calendar years and tenure for non-governmental members shall not more than two terms and (iii) three members of the committee shall constitute the quorum.

Function of this committee:-

1. To grant, suspend or cancel "Certificate of Approval" of a private place (clinical establishment) for MTP service.
2. To supervise the implementation of the provision of the Act and Rules.
3. To enforce standards prescribed for the safe and hygienic MTP service for the private places (clinical establishment).
4. To investigate complaints of breach of the provisions of the Act or Rules made there under and take immediate action and to make communication with the District C.E. Licensing authority
