**NOTIFICATION**

The Governor has been pleased to allow Dr. Soma Ghosh, Medical Officer, MR Bangur MS/SS Hospital, Kolkata, who has completed 16 (sixteen) years' continuous and satisfactory service from the date of her regular appointment in the said service without any promotion and with one advancement to the next higher scale and now enjoying the Scale of Pay Band-4A, Rs.15,600-42,000/-+Grade Pay of Rs.6,600/-, to move to the next higher scale of Pay Band-4B, Rs.28,000-52,000/-+Grade Pay of Rs.7,600/-under W.B.S.(ROPA) Rules, 2009, and its corresponding revised Pay "Level- 19" under W.B.S.(ROPA) Rules, 2019 with effect from **16.02.2020**.

On her entitlement to the higher scale of pay of Rs.28,000-52,000/-+Grade Pay of Rs.7,600/-under W.B.S.(ROPA) Rules, 2009, and its corresponding revised Pay "Level- 19" under W.B.S.(ROPA) Rules, 2019, the pay of the concerned Medical Officer shall be fixed in terms of Finance Department's Memo. No.3015 – F, dt.13.03.2001 as also under normal rules. Besides, the said Officer would also be entitled to the pay and allowances as admissible to her in terms of rules & orders of the State Government in force from time to time.

While giving the effect to the above benefits to the concerned Officer the date of her joining in the West Bengal Health Services on regular basis, AND NOT ON ADHOC BASIS, as also continuity of the service should strictly be verified by the heads of the institutions vis-à-vis the entries in her Service Book. Discrepancies, if any subsequently be found, shall immediately be brought to the notice of this Department for taking further necessary action prior to giving effect to this order in respect of the said concerned Officer.
