Dear Sir/Ma'am,

Reference to the above, notice was issued for granting extension of the renewal agreement from time to time for FPMS after completion of a term of 4+4 years of initial agreement period. It has been seen that the extension period of 91 FPMS (Annexure 1) have either expired or will expire by December 2022.

*Approval is hereby granted for further extension of the existing agreement of the 91 FPMS from the date of expiry of the present extension order till 31<sup>st</sup> March, 2023 or selection of new partner through tender process whichever is earlier, on the following conditions; - ( The details of 91 FPMS is provided in Annexure -I )*

1. For purpose of calculation of the expiry date of the existing renewal agreement, the effective date of the renewal agreement as mentioned in the departmental renewal approval order has to be considered.
2. The hospital authority and the private partner will sign an addendum to this effect as per the format given in Annexure II.
3. All other terms and conditions of the renewal agreement will remain unchanged until further orders. All dues including rent and electricity has to be cleared till date by the private partner before signing of the addendum.
4. The addendum will be prepared in non-judicial stamp paper of Rs. 100/- by the private partners for running the Fair Price Medicine Shops. The performance security has to be extended with the concerned bank in non-judicial stamp paper of Rs. 50/- .
5. Before signing the addendum, the hospital authority will verify all the documents related to renewal agreement. The validity of existing BG will be extended up to 30<sup>th</sup> June 2023.
