
2. They will continue provisionally for 6 (six) months or until further orders with effect from their respective date of joining. If any declaration given or information furnished by any candidate is proved to be false subsequently or in case of any adverse observation during verification of their antecedents or if anyone is found to have willfully suppressed any material information, the concerned candidate will be liable for removal from service without assigning any reason and / or any such further action as Government may deem necessary under the provision of law.

3. The pay of the candidates upon appointment as Professor shall be fixed in the revised pay structures (Rs. 67,300/- - 1,73,200/₹) in Level-17 under WBS (ROPA) Rules, 2019 vide Notification No. 5562-F dated 25.09.2019 of Finance Department (Audit Branch), Govt. of West Bengal.

4. The appointees shall be governed by the terms and conditions of the State Govt. Service Rules and all other rules and orders of the State Govt. as are applicable to the State Govt. employees of similar categories, shall also apply mutatis and mutandis, in respect of the candidates.

5. The appointment carries with it the liabilities of service in any part of West Bengal or outside. The appointees are required to perform all such duties as may be assigned to them time to time besides the duties of the post in which they are appointed. All subsequent orders issued by the State Govt. apropos service terms, condition and pay etc, shall apply towards them.

6. The appointee concerned is hereby directed to report herself for duty to the Head of the Institution concerned immediately and in no case later than 4 (four) weeks from the date of issue of this order, failing which the offer of appointment to post of Professor under the cadre of West Bengal General Services (Nursing) shall stand automatically cancelled without further reference



and vacancy will be filled up by the empanelled candidates as recommended by West Bengal Health Recruitment Board, Kolkata.

7. If the concerned appointee was working previously in this Govt. service and applied for the said post with proper NOC from the concerned authorities, she may apply for counting of past services as regular and continuous services and also for pay guard/pay protection through proper channel to this Department.

8. No T.A. / D.A. are admissible for joining the posts.

9. The appointees are debarred from undertaking private professional assignments of any kind, what so ever including Laboratory, consultancy practice, coaching students etc.

10. This appointment has been made as per the recommendations of West Bengal Health Recruitment Board, Kolkata by way of Direct Recruitment in accordance with the exemption permitted in terms of G.O. No. 4969-F(P) dated 20.06.2013, in terms of Recruitment Rules notified under G.O. No. HF/O/MERT/1561/GA(Nursing)/1N-76/2012 dated 30.12.2013 and Notification No. 100/HF/O/GA(Ng)/1N-103/2018 dated 09.08.2018.


