**ORDER**

**(Partial modification of AAFS No HFW-38011(52)/60/2021-MC/3689 dtd 3.12.21)**

Rs 2,25,923 was sanctioned and released in favour of Principal, Medinipur Medical College & Hospital for Installation of Pipe line from 2 nos of PSA to 2 nos of Manifold Room at Midnapur MC&H, Paschim Medinipur vide this Department's AAFS No HFW-38011(52)/60/2021-MC/3689 dtd 3.12.21. Now, Principal, Medinipur Medical College & Hospital, vide his letter No MMC/1498 dtd 31.5.2022, has informed that the said work was executed through WBMSCL.

6. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and **data entry in NHM-PMS portal must be ensured by the concerned facility.**

7. This is issued with the approval of Mission Director, NHM & Secretary of this Department.


