DHS (Accounts), Directorate of Health Services, West Bengal. The Treasury shall be KPAO-III with Treasury Code-CAF.

3. The said Head of Account has been activated now for Online & Offline receipts through "GRIPS." The Senior Resident Doctor(s) are hereby **permitted** to debit the amount from their self account (not of parents or spouse) through **GRIPS** of **IFMS** Portal vide 'Memorandum' No. 911-F(Y) Dated 28.02.2023 of the Finance Department.

4. After Deposition of money, the SR Doctors are also directed to **submit** the copies of "e-Receipts" , payment order, account statement to the ADHS (P&E), Directorate of Health Services, W.B. which will be forwarded to the ADHS (Accounts) to obtain 'credit verification statement'. Original documents will be released only after obtaining the 'credit verification statement' from the competent authority. It may take **7** (seven) **working days** to complete the procedure.


