O R D E R

The undersigned is directed by order of the Governor to say that the Governor has been pleased to fix the consolidated remuneration of the Part Time Teachers of Homoeopathic Medical Colleges w.e.f. 01.01.2021 as follows.

- (i) PTTs having P.G. Degree (as per CCH norms) with 10 years' service : Rs.35,000/-
- (ii) PTTs having P.G. Degree (as per CCH norms) with less than 10 years' service : Rs.31,000/-
- (iii) PTTs not having P.G. Degree with 10 years' service : Rs.25,000/-
- (iv) PTTs not having P.G. Degree with less than 10 years' service : Rs.20,000/-


Provided the duration of their taking classes including OPD/IPD duties in a week be made same as that of State Aided College Teachers Category-I & State Aided College Teachers Category-II.

2. In addition to the above remuneration, they will be entitled to the following :

- (i) Enhancement of remuneration @3% on 1<sup>st</sup> January every year.
- (ii) Tenure of engagement upto 60 years.
- (iii) Terminal benefit of Rs.5 Lakh (provided rendered service for at least 10 years).

This order issues with the concurrence of the Finance Department, vide their U.O. No. Group P1/2021-2022/0216 dated 20.09.2021.


