**CIRCULAR**

It is being informed to all MSVP and Superintendents of the Medical Colleges/District Hospitals and other hospitals that, the tenure of present batch of house staffs in different disciplines in the said Hospitals concerned may be extended up to 31st May, 2023.

Further all MSVP and Superintendents of the Medical Colleges/District Hospitals and other hospitals are informed that, the selection of House staffs in this year (2023-2024) will be held in decentralized way like previous years and will take effect from 1<sup>st</sup> June, 2023.

The selection procedure may be conducted locally by the concerned hospital authorities as per Government guidelines issued from time to time in this regard. Accordingly, the notice for engagement of House-staffs may be issued by the concerned hospital authorities so that the total process will be completed within appropriate time.


The MSVP and Superintendents of the Medical Colleges/District Hospitals and other hospitals having Sanctioned Posts of House-Staff are empowered to appoint Stipendiary House-Staff locally according to their sanctioned posts following the existing rules & guidelines vide memo. No. ME/HS-03-10/M/616 dated 25.04.2013. After completion of the selection procedure, the total list of selected House staff is to be submitted to this end for necessary approval. After getting approval, engagement letter may be issued to the concerned candidates according to the vacant posts.

All candidates are requested to apply to the concerned authorities of the Medical College or other health institution of their choice as per notification of the respective health institution.

This will take immediate effect until further order.
