ORDER

In view of the health emergency that has occurred due to outbreak of COVID-19, immediate provision of new covid hospitals, augmentation of beds in CCU/HDU at different hospitals, setting up labs were arranged in the exigency basis in the State. Accordingly, decision was taken to set up 300 bed (including 40 bed HDU) at the Kolkata Police Hospital on urgent basis to combat increasing cases of COVID-19.

Post-facto approval was accorded in favour of The Chief Engineer (Electrical), Public Works Department, Nabanna by this Department's order No No 155-HFW-40099/27/2021-HA(PHP) dtd 7.6.2021 for inviting short NIQ in respect of Electrical installation works at Kolkata Police Hospital to make it functional as COVID hospital.

The work has been executed by the Executive Engineer Kolkata South Health Electrical Division P.W.Dte. and he was requested to inform the actual expenditure of the works. In reply, Executive Engineer Kolkata South Health Electrical Division P.W.Dte, vide his Memo No 1295 dtd 16.7.2021, has informed the actual expenditure of the following works:



This order is issued with the approval of the competent authority of department of Health & Family Welfare, Govt. of WB.


