

ORDER

To combat surge of Covid-19 cases, Rs. 2,85,495 was issued out of the ECRP-II (RT-PCR Lab strengthening) in favour of the Drug and Equipment Branch of this Department for procurement of 7 CAT items and supply to 29 RT-PCR labs for Covid test vide No HFW-41015(99)/31/2021-WBMSCL SEC-Dept. of H&FW/152 dtd 14.1.2022. D&E Branch has now requested to issue AAFS of additional amount of Rs. 15,294 on account of payment of GST which was not included in the original AAFS.

- 2. In view of above, the undersigned is directed to accord Administrative Approval of Rs. 15,294 (Rupees fifteen thousand two hundred ninety four) only in favour of Drug & Equipment Branch for payment of GST in connection with procurement and supply of 7 nos of CAT items to 29 RT-PCR labs for Covid test.
- 3. No fund will be released initially. The bills will be paid under the activity head, Lab Strengthening for RT-PCR (ECRP-II) [RoP Code: S.1.2.1] [Tally Code: SA.1.2] under ECRP-II after procurement of the items.
- 4. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund at the time of payment of bills.
- 5. The utilisation will be reflected by the institution in prescribed monthly FMR of ECRP-II, submitted to State FMG, NHM, WB.
- 6. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and data entry in NHM-PMS portal must be ensured by the concerned facility.
- 7. This is issued with the approval of Mission Director, NHM & Secretary, Health & Family Welfare Department.
