

MEMORANDUM

1. In terms of the Memo No. HF/O/HS (MA)/837/HFW-25099/19/2019-MA Dated Kolkata, 11th June, 2021 of the Department of Health & Family Welfare, Government of West Bengal, a total of 501 (five hundred one only) candidates may be placed on Trainee Reserve in the year 2021-2022.
2. In keeping with the above, the Officer(s) of the WBHS/WBPH&AS as shown in the Annexure-I in column [B], under the cadre as mentioned in column [C] with their present place of posting in column [D], are provisionally permitted to undertake post doctoral degree /postgraduate degree/diploma course in the discipline as noted against the candidate(s) in column [E], under the University/Institute as mentioned in column [G], for the session 2021-2022.
For that purpose the candidate(s) are placed on Trainee Reserve for the period as mentioned against their names in column [H] with effect from the respective date of release from their present place of posting.
3. The Officer(s) of the WBHS/WBPH&AS are to be released under local arrangement from their present places of posting by the concerned controlling authority in order to enable them to join the course, after handing over their official charges.
4. Meanwhile, if on scrutiny and vigilance verification the candidates are found to have been suppressing facts or furnishing false information, or in case of any adverse report, their candidature will be liable to be cancelled and appropriate administrative action will be initiated against them as per rules.
5. During the period of Trainee Reserve, the Officers will draw Pay & Allowances as admissible to them, in terms of the existing rules of this State Government.
6. The Medical Officer(s), as placed on Trainee Reserve are subject to the condition that they shall, prior to their drawing Pay as Medical Officer on Trainee Reserve, execute bond in the prescribed format in non judicial stamp paper with three additional copies containing all original signatures, undertaking to serve this State Government for a period of at least three years (for course of two years duration) and at least five years (for course of three years duration) after completion of the course. The duly filled up bond should be submitted to the MERT Branch of the Department of Health & Family Welfare, Swasthya Bhawan, Kolkata for acceptance.
7. The Assistant Director of Health services (Accounts) will act as the DDO in this regard and the University / Institute shall submit the working statement and requisite reports in respect of the Medical Officer(s).
8. The Pay & Accounts Officer-III, Kolkata, Accountant General, West Bengal and other concerned are being informed.
9. The officers shall obtain release order from the concerned Institution immediately after completion of the TR period and report to the Director of Health Services, West Bengal for duty.
10. This Memorandum is issued in accordance with the Order No. HF/O/MA/641/ HFW-25099/54/2021-MA dated 6th April 2021 of the Department of Health & Family Welfare, Government of West Bengal.




