ORDER

The Department of Health and Family Welfare, Govt of West Bengal has decided to construct permanent Covid Units at different health facilities under the ECRP-II fund for management of Covid-19 patients. Accordingly, fund of Rs 432.63 Crore (Rs 307,76,54,905 + Rs 3,94,90,590 + Rs 119,84,98,423 + Rs 87,75,713) has already been sanctioned for allotment to PWD, GTA and WBMSCL previously for construction of 24 numbers of 100-bed Covid wards, 6 number of 50-bed Covid wards, 118 numbers of 20-bed Covid wards and vertical extension of one Covid ward at different hospitals

Now, PWD has submitted estimate for vertical extension work of Covid ward at Medinipur MCH, Paschim Medinipur.

In view of the above, the undersigned is directed to accord Administrative Approval and Financial Sanction of Rs. 13,40,18,693 (Rupees thirteen crore forty lakh eighteen thousand six hundred ninety three) in favour of **Principal, Medinipur Medical College & Hospital** for vertical extension work of Covid ward at Medinipur MCH, Paschim Medinipur.

The fund is placed against the activity head, ICU Beds added at other Public Healthcare Facilities (ECRP-II) [RoP Code: S.2.4.5] [Tally Code: SA.2.4.5] under ECRP-II.

Principal, Medinipur Medical College & Hospital is requested to release fund to the concerned **Executive Engineer, PWD** after receiving requirement of fund for the approved works.

Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund.

Works will be taken up by the respective PWD divisions. **The utilisation will be reflected by the Institution in the prescribed monthly FMR of ECRP-II, submitted to State FMG, NHM, WB.**

Strict compliance with all financial norms in respect of incurring expenditure out of the said fund must be followed and **data entry in NHM-PMS portal must be ensured by the concerned facility.**

This is issued with the approval of Finance Department vide UO No Group O/2022-2023/0017 dtd 29.6.2022 .


