



ORDER

To combat probable 3rd surge of Covid-19 cases, this Department has decided to establish 24 bed Hybrid Critical Care Unit (8 CCU beds and 16 HDU beds) at 79 MCH/DH/SDH/SSH across the State under ECRP-II fund vide order No HFW-14014(11)/2/2021-SPSRC/301 dtd 7.9.2021. It was assessed that minor civil, electrical works, installation of negative pressure ventilation, MGPS extension would be required at 79 hospitals before installation of equipment. Accordingly, West Bengal Medical Service Corporation Ltd has requested to accord AAFS of of Rs. 1,27,17,417 for Design, Supply, Installation, Commissioning, Operation & Maintenance of Medical Gas Pipeline System(MGPS)at Mekhliganj SDH of West Bengal for 5 years that they can issue Award of Contract to the selected agency namely M/S Ovaron Infrastructure & MEP Services.

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of Rs. **1,27,17,417 (Rupees one crore twenty seven lakh seventeen thousand four hundred seventeen) only** in favour of **West Bengal Medical Service Corporation Ltd** for Design, Supply, Installation, Commissioning, Operation & Maintenance of Medical Gas Pipeline System(MGPS)at Mekhliganj SDH of West Bengal for 5 years.

3. **The fund of Rs. 1,27,17,417/- is placed against the activity head, Support for Liquid Medical Oxygen Plant with MGPS (ECRP-II) [RoP Code: S.2.7] [Tally Code: SA.2.7] under ECRP-II.**

4. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund.

5. Managing Director, West Bengal Medical Service Corporation Ltd will issue Award of Contract to the selected agency and release the requisite fund mainlining existing financial norms.

6. **The utilisation certificate will be submitted by the organisation in format of GFR-12C to State FMG, NHM, WB.**

7. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and **data entry in NHM-PMS portal must be ensured by the concerned facility.**


