Sub: - Operation and Maintenance issue of PSA plants

Sir/ Madam,

Apropos the above subject matter, PSA Oxygen plants are already commissioned in several hospitals by GOI as well as donation agencies. Some of the plants are made functional whereas in other sites commissioned plants are yet to be made functional based on several issues like collection and supply of oxygen purity report, engagement of O&M agencies to operate the plant. The department has already entrusted WBMSCL to finalize and implement the O&M agencies which is under active consideration.

However considering the present urgency to make all the Commissioned PSA plants functional immediately, hospital authorities are hereby requested to issue necessary orders to existing MGPS maintenance agencies to operate the PSA plants on temporary basis for next three months or until further orders whichever earlier. The necessary expenses for the same will be provided by the department from suitable fund sources after confirmation from hospitals authorities regarding deployment of services and functionality report of the PSA plants. Concerned District Magistrates, ADMs and District Nodal officers for PSA may kindly ensure early implementation.

This may be treated as most urgent.
