ORDER

To combat probable 3rd surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. Thus, PWD and other agencies have been requested to take up requisite civil, electrical and MGPS related works at the concerned health facilities. Accordingly, estimate has been received from selected agency through Principal, Dr B C Roy PGIPS with request to issue AAFS.

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of Rs 7,23,364 (Rupees seven lakh twenty three thousand three hundred sixty four) only in favour of Principal, Dr. B.C. Roy PGIPS for executing the below mentioned work:

4. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund.


5. Principal, Dr. B.C. Roy PGIPS is requested to sub-allot the fund to the concerned agency.

8. This is issued with the approval of Mission Director, NHM & Secretary of this Department.


