ORDER

To combat probable 3rd surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. Thus, PWD and other agencies have been requested to take up requisite civil, electrical and MGPS related works at the concerned health facilities. Accordingly, estimate has been received from selected agency through Principal, R G Kar MCH with request to issue AAFS.

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of Rs 3,09,433 (Rupees three lakh nine thousand four hundred thirty three) only in favour of Principal, R G Kar MCH for executing the below mentioned work:

4. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund.


5. Principal, R G Kar MCH is requested to sub-allot the fund to the concerned PWD division.

8. This is issued with the approval of Mission Director, NHM & Secretary of this Department.


