NOTIFICATION

In exercise of the power conferred by Section 4, Clause (iii) (a), Surrogacy (Regulation) Act, 2021, the Governor is hereby pleased to nominate the following persons as members of the **District Medical Board** for each of the districts (revenue and health dist) for the purpose of the said Act with immediate effect and until further order.

A. Composition of **District Medical Board**, other than Kolkata District:


- (a) Chief Medical Officer of Health of the district—Chairperson;
- (b) Head of the Department or In charge, Gynecology & Obstetrics dept. of Govt. Medical College Hospital or District Hospital, whichever is applicable—Specialist member;
- (c) Head of the Department or In charge, Pediatrics dept. of Govt. Medical College Hospital or District Hospital, whichever is applicable—Specialist member.

B. Composition of **District Medical Board** for Kolkata District:

- (a) Dy. Director of Health Services (Admin), Dept. of Health & Family Welfare, Govt. of West Bengal---- Chairperson;
- (b) Prof. Rajendra Prasad Ganguly, Dept. of Gynae & Obs. R. G. Kar Medical College & Hospital, Kolkata-- Specialist member;
- (c) Prof. Sankar Kumar Das, Dept. of Pediatrics. Medical College & Hospital, Kolkata-- Specialist member.

Purpose of the District Medical Board:

To assist the State Appropriate Authority under the Surrogacy (Regulation) Act, 2021, by issuing a "Certificate of Medical Indication" in favour of either or both members of intending couple necessitating gestational surrogacy.
