ORDER

I have been directed to re-organize different branches under this Department for better and effective functioning of the different programme under NCD, focusing on secondary health care for optimal utilization of hospital services and strengthening of Multispecialty hospitals, effective implementation of Telemedicine, strengthening of Urban health, PC & PNDD, addressing the issues with specially able person including certification and implementing National Mental health Programme. Henceforth following officers will look after the different components and programmes as follows:

[A] **Dr. Siddhartha Niyogy**, Jt. DHS (Nutrition) has been assigned to look after the activities of Hospital Administration Branch as OSD & Jt.DHS as per directorate order bearing no. HPT/32M-139-2021/A 3939 dated 09/08/2021. He will supervise overall activities of this branch.

[B] **Dr. Subhrangshu Chakraborty**, Deputy Director of Health Service will look after the following components of **Hospital Administration branch**

- a. Gap analysis in terms of Infrastructure, HR, Training and performance
- b. Ensuring quality of service including diet, cleaning and security services and BMW management,
- c. Implementation of Diagnostic services as per norm
- d. Ensuring smooth referral and optimal utilization of all resources
- e. Rational use of Drugs and other logistics and ensuring availability
- f. Special service and PPP service planning and monitoring
- g. Optimal functioning of all Health facility with special focus of Multi-specialty hospitals, Burn and Trauma care units
- h. Planning, implementation and monitoring of Tele-medicine service at secondary and tertiary tier hospitals.
- i. Will prepare a Vision document for the overall service delivery in the primary and secondary tier hospitals of the State

[C] **Dr. Somnath Mukherjee**, Deputy Director of Health Service will look after the following program / components under Non-Communicable Disease (Division-I)

- a. National Programme for Prevention and Control of Cancer, Diabetes, Cardio-vascular diseases and Stroke (NPCDCS)
- b. National Programme for Health Care of Elderly (NPHCE).
- c. National Programme for control of Haemoglobinopathies (NPCH)
- d. National Oral Health Program
- e. National Programme for Palliative Care

In addition, he will look after the issues of Tele-medicine and National Urban Health Mission.

[D] **Dr. Debasish Halder**, Deputy Director of Health Service will look after the following program / components under Non-Communicable Disease (Division-II)

- a. National Mental Health Programme (NMHP)
- b. National Tobacco Control Programme (NTCP)
- c. National Blindness Control Programme (NPCB)
- d. National Iodine Deficiency Disorder Control Programme (NIDDCP)
- e. National Programme for Prevention and Control of Deafness (NPPCD)
- f. National Fluorosis Control Programme (NFCP)
- g. Arsenic control Programme (ACP)

In addition, he will look after the issues of Physically Challenged person including Disability certification.

All Files of NCD branch of this Directorate will be routed through Joint DHS (NCD).

[E] **Dr. Kajal Kumar Mondal**, Deputy Director of Health Service will look after all the issues of Deputy Director of Health Service, Family Welfare, under supervision of SFWO. Additionally he will look after the issues of Implementation of PC and PNDT Acts.


