ORDER

This Department has signed MoU with the Tata Memorial Centre (TMC), Mumbai for setting up two 'State of the Art' Cancer Hubs at IPGMER, Kolkata and NBMCH, Siliguri in technical collaboration with TMC, Mumbai. As per the MoU, total 38 doctors and other para medical staff of IPGMER and NBMCH have so far been sent to TMC, Mumbai for skill enhancement training. Cost of transport, lodging and food in Mumbai has been borne by the concerned MCHs or persons concerned.

Administrative Approval was accorded for total expenditure for this purpose i.e. Rs 11,06,122 (Rs 5,11,880 for IPGMER and Rs 5,94,242 for NBMCH) and Rs. 2,10,000 was sanctioned and released previously to Director, IPGMER vide order no. 389/HFW 18021/6/2022/PHP dated: 04.07.22 to meet up the expenditures.


Now, the undersigned is directed by the order of the Governor to say that the Governor has been pleased to accord further Financial Sanction of Rs 3,01,880 (Rupees three lakh one thousand and eight hundred eighty) in favour of the Director, IPGMER for cost of exposure visit of officials of IPGMER to TMC, Mumbai. .

The fund will be released from the head of account "24-2210-01-110-053-50-00-V" in the current Financial Year 2022-23.

Accounts Officer, IPGMER & SSKM Hospital will act as D.D.O. in respect of the fund being placed and he is requested to kindly arrange payment by observing existing financial norms.
