Dr Protik Mondal, ex-Senior Resident, presently posted as M.O.(Specialist) at Digha SGH, under CMOH, Nandigram Health District, Paschim Medinipur, **joined** as Senior Resident/ Contractual Medical Officer under CMOH Diamond Harbour Health District on **06/07/2020** and he served there up to 10/06/2022. Later Dr Mondal joined under WBHS as M.O.(Specialist) at Digha SGH, under CMOH Nandigram HD on 14/06/2022. He is till working at Digha SGH.

Due to his innocence of the matter that his service under WBHS as M.O.(Specialist) will be counted as bond service of 'Senior Resident', Dr Mondal applied to the authority for deposition of bond money and he has deposited the bond amount of **Rupees Ten Lakh** in favour of Joint DHS(Accounts) for release of his original documents.

Afterwards, Dr Mondal stated that his father-in-law is getting Chemotherapy and there are **no one but he** to bear the expenses of his medical treatment. Dr Mondal appealed to the authority to do the needful for refund of bond amount of Rupees Ten Lakh as deposited by him considering his **financial hardship**.

Dr Mondal has submitted an 'AFFIDAVIT' before the **1st Class Judicial Magistrate (5th Court), Sealdah** that he will continue his service as M.O.(Specialist) at Digha SGH.

The matter has been **reviewed** by the authority in light of the existing rules and present situation. In consideration of his prayer dated 24/08/2022 and considering his **financial hardship**, Assistant Director of Health Services (Accounts) is hereby **requested** to arrange for refund of bond amount of Rupees Ten Lakh as deposited by Dr Protik Mondal. All concerned are informed accordingly.
