**NOTIFICATION**

The Governor has been pleased to allow Dr. Ishita Dutta, Medical Officer, Basirhat Dist. Hospital, North 24 Parganas, who has completed 8 (eight) years' continuous and satisfactory service from the date of her regular appointment in the said service without any promotion and was enjoying to move to the next higher Scale under Pay Band-4A, i.e. Rs. 15,600-42,000/- +Grade Pay of Rs.6,600/-under W.B.S.(ROPA) Rules,2009 and its corresponding revised Pay "Level- 17" under W.B.S.(ROPA) Rules, 2019 with effect from **06.12.2020**.

On her entitlement to the higher Scale under Pay Band-4A, i.e. Rs. 15,600-42,000/- +Grade Pay of Rs.6,600/-under W.B.S.(ROPA) Rules,2009 and its corresponding revised Pay "Level- 17" under W.B.S.(ROPA) Rules, 2019, the pay of the Medical Officer shall be fixed in terms of Finance Department's Memo. No.3015 – F, dt.13.03.2001. Besides, the said Medical Officer would also be entitled to the pay and allowances as admissible to her in terms of rules & orders of the State Government in force from time to time.

While giving the effect to the above benefits to the concerned Medical Officer the date of her joining the West Bengal Health Services on regular basis, AND NOT ON ADHOC BASIS, as also continuity of her service should strictly be verified by the head of the institution vis-à-vis the entries in her Service Book. Discrepancies, if any subsequently been found, shall immediately be brought to the notice of this Department for taking further necessary action prior to giving effect to this order in respect of the said concerned Medical Officer.

The above benefit has been awarded under the modified career advancement scheme in terms of the Finance Department's Memo. No.3015 – F, dt.13.03.2001 .
