For active control and case management of H1N1 cases across the State, this Department has decided to procure and supply of PCR Kits and consumables to ten (10) State run Labs in connection with testing of H1N1. 
The fund will be released from the head of account "2210-06-796-006-50-00" in the current Financial Year 2022-23.
