

On scrutiny of all documents/papers as you have sent at this end regarding the aforesaid subject and reference nos. it appears that Smt Mitra has refunded her last three month's salary Rs.89,559/- for her resignation and Rs.1,50,152/- as her overdrawn salary for the period from March-2019 to July-2019 through T.R. Form No.-7. But, as per Rule 34 A of WBSR Pt.-I, here, the incumbent has to refund only last one month's salary and the overdrawn amount , if any. Smt. Mitra tenders her prayer for resignation w.e.f. 24.02.2019 (F/N). So, she has overdrawn 5 days salary in the month of February-2019 also. She had to refund last one month's Gross salary Rs.29,853/- plus 5 days overdrawn salary of February-2019 i.e. Rs.5331/- [Rs.29,853 X 5/28]. Therefore, she would have to refund Rs.29,853/- as last month's salary and Rs. (5331+1,50,152)/- as overdrawn amount. But, Smt. Mitra has refunded Rs. (89,559/+1,50,152)/-. Therefore, you are requested to clarify why the incumbent had to pay such amount of money for her resignation.

Please attach a salary statement for the period from December-2018 to February-2019 also.
