ORDER


Whereas, the collection, transportation, treatment, and disposal of common bio-medical wastes from different public health facilities down to the level of Primary Health Center (PHC) including U-PHCs is an essential criterion in order to make compliance with the standard protocol of the West Bengal Pollution Control Board.

Whereas, no uniform rate was fixed in previous occasions for disposal of bio-medical wastes from any non-bedded health facility like Urban Primary Health Center (U-PHC), due to which the disposal of bio-medical wastes from the U-PHCs could not be implemented across the State in uniform manner.

Thus, considering the necessity of the situation, a uniform rate amounting to Rs. 1500/- (Rupees one thousand five hundred) only per month per U-PHC has been finalized with the condition that the respective CBMWTF operators, assigned for different CBMWTF regions across the State, should lift bio-medical wastes at least thrice a week. Subsequently, respective operators will be eligible to claim for reimbursement of funds. Other terms and conditions for such disposal shall remain unchanged as per the master agreement signed with this Department.


This will come into effect from the 1st of July, 2022 or the date of signing the service level agreement between the CBMWTF operator and the Urban Local Bodies, whichever is later. This Order is issued with the concurrence of the Finance Department vide their U.O. No. Group O/2022-2023/0011 dated: 08.06.2022.
