ORDER

Smt. Sarmistha Sengupta, Ex- Nursing Superintendent, lastly attached to The Calcutta Homeopathy Medical College & Hospital, Kolkata, took many short spell leave from 07.08.2001 to 17.11.2005 i.e. 245 days in total which is less than 5 years.

As on 07.08.2001 only 4 days El and 167 days HPL leave means $(167/2 = 83 \text{ days})$ were in her credit.

She already retired from her service w.e.f. 31.01.2023.


Total E.O.L = 158 days
