

Later he was transferred to Raiganj Govt. Medical College and he joined there on 25/03/2022. He performed his duties there up to 02/06/2022. Prior joining MS (Gen. Surgery) course, Dr Islam joined as RMO-CT (Anaesthesiology), Malda Medical College on 22/03/2017. Dr Islam tendered his resignation on 10/04/2018 and sought effect from 11/05/2018 for undergoing MS (Gen. Surgery) course from N.B.M.C., Darjeeling. As his resignation was not accepted, after completion of MS (Gen. Surgery) course, Dr Islam appealed to the authority for resumption of his duty as RMO-CT, Malda Medical College. In consideration of his prayer dated 31/08/2021 and as per approval of the Secretary of this Department, Dr Islam was permitted to resume his duty as RMO-CT (Anaesthesiology), Malda Medical College vide Notification No. HF/O/MA(MES)/670/ ME/MISC-130-2021 Dated 27/05/2022.




