**ORDER**


Vide this Department Memorandum no. HF/O/MERT/1310/ME/MISC-78-13 dated 02.12.2016, whereby the defaulting candidates (Post Graduate Trainees of MD/MS/MCh/DM/Diploma Courses failed to fulfil the criteria laid down in the Notification no. HF/O/MERT/912/ME/MISC-78-13 dated 31.07.2013 & Notification No. HF/O/MERT/923/ME/MISC-78-13 dated 10.06.2014) deposited the penal amount (as applicable) in the Head of Account "8443-00-Civil Deposit-106-Personal Deposits-007-Miscellaneous Deposits-07-Deposits" (Account Code: 84430010600707) in favour of Joint DHS (Accounts), Directorate of Health Services, West Bengal, Treasury KPAO-III.

It has been observed that the penal amount deposited in the HoA is lying unutilized, hence after careful consideration, the undersigned is directed by order of the Governor to convey that the Governor has been pleased to create a new receipt Head of Account "0210-03-105-009-06-Penalty Against Executing Bond" which has been detailed as "0210 Medical and Public Health-03 MEDICAL EDUCATION, TRAINING AND RESEARCH-105 Allopathy-009 Penalty Against Executing Bond-06 Fines/Forfeitures/Penalties/Confiscation" for the deposition of penalty amount against Indemnity Bond executed in terms of Notification no. HF/O/MERT/923/ME/MISC-78-13 dated 10.06.2014 in place of the HOA "8443-00-Civil Deposit-106-Personal Deposits-007-Miscellaneous Deposits-07-Deposits".

Henceforth, the defaulting candidates shall deposit the penal amount (as applicable) in the newly created HoA "0210 Medical and Public Health-03 MEDICAL EDUCATION, TRAINING AND RESEARCH-105 Allopathy-009 Penalty Against Executing Bond-06 Fines/Forfeitures/Penalties/Confiscation" in place of the HOA "8443-00-Civil Deposit-106-Personal Deposits-007-Miscellaneous Deposits-07-Deposits".
