4. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund.


5. Managing Director, West Bengal Medical Services Corporation Ltd is requested to kindly sub-allot the fund to concerned vendors/ suppliers

9. All concerned are being informed.




