ORDER

To combat probable 3rd surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. Thus, PWD has been requested to take up requisite civil and electrical works at the concerned health facilities. Accordingly, estimate has been received from PWD through Director, IPGMER for following three number of works with request to issue AAFS:

4. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund.


5. Works will be taken up by the respective PWD offices. **Director, IPGMER will sub-allot the fund to the concerned PWD division/ executing agency.**

9. All concerned are being informed.




