ORDER

Administrative Approval was accorded out of ECRP-II in favour of WBMSCL for procurement and supply of one CT scan machine at Islampur SDH vide No HFW-18099/44/2022-PHP/2050 dtd 21.6.2022. WBMSCL has finalized agency and issued Award of Contract accordingly. In connection with that WBMSCL has requested to release of Rs 3,42,70,000 for subsequent transfer to the supplier.

2. In view of above, the undersigned is directed to accord revised Administrative Approval and Financial sanction of **Rs. 3,42,70,000 (Rupees three crore forty two lakh seventy thousand)only** in favour of **West Bengal Medical Services Corporation Ltd** for procurement and supply of one CT scan machine at Islampur SDH.
