**ORDER**

To combat probable 3<sup>rd</sup> surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. Thus, PWD has been requested to take up requisite civil and electrical works at the concerned health facilities. Accordingly, estimates have been received from PWD through Chief Medical Officer of Health, South 24 Parganas and Superintendent, Durgapur SDH for two number of works with request to issue AAFS:

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of **Rs 25,00,352 (Rupees twenty five lakh three hundred fifty two) only** in favour of West Bengal Medical Services Corporation Limited for executing the following works.


