ORDER

To combat probable 3rd surge of Covid-19 cases, it has been decided to increase Covid CCU/HDU beds upto 4600 beds and set up 1300 Covid PICU beds Covid wards in the State to combat 3rd surge of Covid cases. Orders have been issued accordingly. WBMSCL was requested to arrange installation of new MGPS/extension of MGPS at the proposed sites. Also, as per direction of Gol, PSA Plants and LMO are being installed at 78 hospitals and 28 hospitals respectively.

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of Rs. 20,56,77,033 (Rupees twenty crore fifty six lakh seventy seven thousand thirty three)only in favour of West Bengal Medical Services Corporation Ltd for executing the following works.

5. Works will be taken up by the respective PWD offices/agencies. Managing Director, West Bengal Medical Services Corporation Ltd is requested to kindly sub-allot the fund to concerned agency.

6. The utilisation certificate will be submitted by the organisation in format of GFR-12C to State FMG, NHM, WB.

7. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and data entry in ECRP-II portal must be ensured by the concerned CMOH/facilities.


