ORDER

Accordingly, AAFS of Rs 21,36,20,768 was issued vide order No HFW-41015(14)/6/2021-WBMSCL SEC-Dept. of H&FW/3099 dtd 8.10.2021 in favour of WBMSCL for procurement and installation of of Syringe Pump Adult & Paediatric, Syringe Pump- Newborn & Infant, Non Invasive BIPAP Ventilator, Blood Gas Analyser, Echo Cardiography Scanning Machine with probes and Bubble CPAP.


