**ORDER**

To combat probable 3<sup>rd</sup> surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. Accordingly, West Bengal Medical Service Corporation Ltd procured equipments like Bubble CPAP, BiPAP, Humidifier, blood gas analyzer etc centrally for augmentation of Adult CCU, PICU beds at Covid wards in the State and placed requisition of fund for procurement of the same.

2. In view of above, the undersigned is directed to accord Administrative Approval and Financial Sanction of **Rs. 9,92,73,839 (Rupees nine crore ninety two lakh seventy three thousand eight hundred thirty nine) only** in favour of **West Bengal Medical Service Corporation Ltd** for procurement of Bubble CPAP, BiPAP, Humidifier etc centrally through GeM portal for augmentation of Adult CCU, PICU beds at Covid wards in the State.

3. The fund of **Rs. 9,92,73,839** is placed against the activity head, **ICU Beds added at District Hospitals (ECRP-II) [RoP Code: S.2.4.2] [Tally Code: SA.2.4.2]** under ECRP-II.

4. Financial Advisor, WBSH&FW Samiti will act as the Drawing & Disbursing Officer for releasing the fund.

5. Managing Director, West Bengal Medical Service Corporation Ltd will sub-allot the fund to the concerned vendors as detailed at annexure A.

6. The utilisation certificate will be submitted by the organisation in format of GFR-12C to State FMG, NHM, WB.

7. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and **data entry in NHM-PMS portal must be ensured by the concerned facility.**

8. This is issued with the approval of Mission Director, NHM & Secretary, Health & Family Welfare Department.




