Resolution of Tender Selection Committee regarding E-Tender for Digital X-Ray (Tender ID-2019_HFW_230775_1), 16 Slice CT Scan (Tender ID-2019_HFW_230633_1), 5 bedded Dialysis Services (Tender ID-2019_HFW_230774_1) at Kakdwip SDH, DHHD under PPP mode on 10.11.2022 at 2.00 PM in the office chamber of the CMOH, Diamond Harbour Health District.

The following resolutions were taken:


1. At the outset, Chief Medical Officer of Health, DHHD made a briefing about the current status of below mention three tenders

2. AOC for EOM of 16 slice CT scan under PPP mode at Kakdwip SDH was issued through West Bengal e-Procurement website on 10.09.2020 in favour of Sanjeebani Clinic Private Limited being H-1 bidder. But till now the same agency is not showing any interest to provide the service. Also tender validity of 180 days has elapsed much earlier.
3. E-Tender for 5 Bedded Dialysis unit has already been cancelled on 21.01.2021 by the Departmental Tender Committee (DTC) due to the violation of Finance Dept. GO no.2254-F(Y) dt.24.04.2014 regarding newspaper advertisement of the tender.

4. On 10.09.2020 an offer letter for EOM of Digital X-Ray was issued in favour of Sanjeebani Clinic Private Limited being H-1 bidder. Since then nothing has happened and also the department doesn't want to go for Digital X-Ray under PPP mode anymore. Also tender validity of 180 days has elapsed much earlier.
5. Therefore, the tender selection committee unanimously decides to cancel all the three tenders with the approval of the competent authority due to various unavoidable circumstances and administrative reason.
