PH Candidates should carry the original and photocopy of the physically handicap certificates issued by the competent authority from the SSKM Medical College & Hospital during admission in respective college. Without these original PH document during verification the admission of the concerned candidate will be cancelled on the spot.

Dates and process for online application, form fill up, counselling, verification of the necessary documents and certificates and admission into two years Diploma Course in Pharmacy in the 3 (three) Govt. Institute of Pharmacy, at Kalyani, Bankura and Jalpaiguri, for the Session of 2021-2022 will be notified in the official website of Department of Health & Family Welfare, Government of West Bengal ([www.wbhealth.gov.in](http://www.wbhealth.gov.in)) in due time. **Therefore, eligible & willing candidates are requested to follow the official website of Department of Health & Family Welfare, Government of West Bengal.**
