2. Last date of submission of the tenders fixed on 20.09.2021 till 12.00 Noon and the same will be opened on the same day at 1.00 P.M by the Tender Selection Committee and the interested bidders may remain present at the opening time of the Tenders.
3. Two Bid systems will be followed. In the technical bid (Annexure A), the bidders shall give the details of the techniques, chemicals, materials and the equipment used along with schedule of visits and treatments. The price bid should (Annexure-B) contain the cost of total amount for per month basis (weekly basis at least 7 days interval). The price bid of the technically qualified bidders will be opened after intimation of the concerned tender.
4. The selected agency must ensure that the Pest Control once done shall remain effective up to next pest control, failing which it shall have to be done again and any cost therefore will not be entertained
5. The pesticides, etc used for pets/termite/rodent control, should not create adverse impacts on human health as well as in patient care services.
6. No Tender will be accepted unless it is accompanied by the following documents:-

 - c) Valid License of Pest Control & Rodent Control
